#### **REFUND / CANCELLATION POLICY**

#### • Tuition Refund Policy

If the student is not accepted, all monies paid in advance shall be refunded. If the student is accepted and then cancels before classes begin, all monies paid in advance shall be refunded. If the student is accepted and subsequently starts, he/she is subject to the Cancellation of Enrollment policy below. The student's last date of attendance is used to determine the refund due. Refund provisions apply only to complete withdrawal from the Academy.

• Should the student's enrollment be terminated or should the student withdraw for any reason, all refunds will be made according to the following refund schedule:

#### **Tuition Reimbursement Scale or Schedule**
